Members will receive 2 Verbal warnings and then 1 Written warning; if not listened to then the member will be out of the Club.
- Would like to propose change to Club members to have dues renewal process change to end of December. This will make it easier to transition to a new Treasurer when the need comes up.
- Hat order is coming, there was an issue with the original logo proposed. It would not have been a good candidate to be embroidered on the hats for legibility. Another logo version is in the works to be shared with the Vendor and then hats should be made up in time for our July Club meeting.
